3             **A RESOLUTION TO THE AUTHORIZE THE CITY MANAGER TO**  
4             **ENTER INTO A CONTRACT WITH MARK McLARTY FORD LINCOLN,**  
5             **IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIXTY-EIGHT**  
6             **THOUSAND, SEVEN HUNDRED TWENTY-TWO AND 40/100 DOLLARS**  
7             **(\$168,722.40), FOR THE PURCHASE OF TWO (2), THREE (3) CUBIC-**  
8             **YARD CREW CAB DUMP TRUCKS, FOR THE PUBLIC WORKS**  
9             **DEPARTMENT; AND FOR OTHER PURPOSES.**

11            **WHEREAS**, there is a need for two (2), Three (3) Cubic-Yard Crew Cab Dump Trucks for use by the  
12 Public Works Department; and,

13            **WHEREAS**, pursuant to Bid No. 17-1181, it was determined that Mark McLarty Ford Lincoln was the  
14 lowest responsible and responsive bidder of the three (3) submitted bids at One Hundred Sixty-Eight  
15 Thousand, Seven Hundred Twenty-Two and 40/100 Dollars (\$168,722.40) for the purchase of two (2),  
16 Three (3) Cubic-Yard Crew Cab Dump Trucks;

17            **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY**  
18 **OF LITTLE ROCK, ARKANSAS:**

19            **Section 1.** The City Manager is authorized to enter into an agreement with Mark McLarty Ford  
20 Lincoln for the purchase of two (2), Three (3) Cubic-Yard Crew Cab Dump Trucks, in an amount not to  
21 exceed One Hundred Sixty-Eight Thousand, Seven Hundred Twenty-Two and 40/100 Dollars  
22 (\$168,722.40).

23            **Section 2.** Funds for this purchase as available in the Public Works Special Projects Accounts No.  
24 205409-72300-S40B611.

25            **Section 3. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or  
26 word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or  
27 adjudication shall not affect the remaining portions of the resolution which shall remain in full force and  
28 effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the  
29 resolution.

30            **Section 4. Repealer.** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with  
31 the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
