Prior to this public hearing, the Consolidated Planning Committee developed a slate of projects to recommend for Board approval. The public hearing will give citizens an additional opportunity to review and comment on the amended uses of the 2017 CDBG funding. The Consolidated Planning Committee is submitting the amended CDBG uses as its recommendation to the Board.</p>
