NARRATIVE

ON MONDAY, OCTOBER 17, 2022, AT APPROXIMATELY 2024 HOURS, OFFICERS WERE DISPATCHED TO A MALE SUBJECT PASSED OUT BY A SMALL SEDAN VEHICLE, LOCATED ON THE FRONTAGE ROAD NOT FAR FROM AMAZON WAREHOUSE. MEMS AND FIRE RESCUE RESPONDED TO THE LOCATION AND LOCATED A WHITE MALE, LATER IDENTIFIED AS LARRY FOSTER LYING ON THE GROUND NEXT TO A VEHICLE, SUFFERING FROM AN APPARENT GUNSHOT WOUND. OFFICERS ARRIVED ON SCENE AND ALSO OBSERVED MR. FOSTER. MEMS PRONOUNCED MR. FOSTER DECEASED ON SCENE. HOMICIDE DETECTIVES AND CRIME SCENE PERSONNEL WERE NOTIFIED AND RESPONDED.

OFFICERS WERE THEN DISPATCHED TO BAPTIST HOSPITAL IN REFERENCE TO A SHOOTING VICTIM ARRIVING AT THE ER. OFFICERS MADE CONTACT WITH A JUVENILE WHO WAS SUFFERING FROM AN APPARENT GUNSHOT WOUND. OFFICERS ALSO MADE CONTACT WITH THE JUVENILE VICTIM'S FATHER, DEMONTRA HATFIELD WHO WAS ALSO AT THE BAPTIST HOSPITAL ER. MR. HATFIELD WAS TRANSPORTED TO THE MAJOR CRIMES DIVISION FOR FURTHER INVESTIGATION. HOMICIDE DETECTIVES MADE CONTACT WITH MR. HATFIELD AT THE MAJOR CRIMES DIVISION. MR. HATFIELD WAS ADVISED HIS MIRANDA RIGHTS. MR. HATFIELD ADVISED HE UNDERSTOOD HIS RIGHTS AND PROVIDED A STATEMENT. AFTER CONCLUSION OF THE INVESTIGATION, MR. HATFIELD WAS CHARGED WITH CAPITAL MURDER, DOMESTIC BATTERY 1ST DEGREE, UNLAWFUL DISCHARGE OF FIREARM FROM VEHICLE, POSSESSION OF FIREARMS BY CERTAIN PERSONS AND ENDANGERING THE WELFARE OF MINOR 1ST DEGREE. MR. HATFIELD WAS TRANSPORTED TO PCRJ.

DURING THE COURSE OF THIS INVESTIGATION, MS. WILDER WAS LOCATED DECEASED. BENTON POLICE DEPARTMENT IS CURRENTLY INVESTIGATING THIS INCIDENT. (BENTON PD INCIDENT 2022-05495).
