## **NARRATIVE**

HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES CANVASSED THE AREA FOR SURVEILLANCE FOOTAGE AND WITNESSES. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TRANSPORTED THE SUBJECT TO THE ARKANSAS STATE CRIME LAB FOR AN AUTOPSY AND POSITIVE IDENTIFICATION. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
