## **NARRATIVE**

ON TUESDAY, FEBRUARY 7TH, 2023 AT APPROXIMATELY 1519 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED AT THE LISTED ADDRESS. COMMUNICATIONS ADVISED THE VICTIM WAS LOCATED NEAR THE INTERSECTION OF WEST DAISY L. GATSON BATES AND BROADWAY STREET. UPON ARRIVAL, OFFICERS LOCATED JUSTIN FLETCHER (B/M; 01/19/1991) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS RESPONDED AND TRANSPORTED MR. FLETCHER TO UAMS WHERE HE SUCCUMBED TO HIS INJURIES. A SECOND VICTIM, IDENTIFIED AS MOHAMED DIOP (B/M; 11/26/2001), LATER RESPONDED TO A LOCAL HOSPITAL SUFFERING FROM AN APPARENT GUNSHOT WOUND SUSTAINED DURING THIS INCIDENT. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND VIDEO SURVEILLANCE. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO UAMS AND TOOK POSSESSION OF MR. FLETCHER FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
