NARRATIVE

ON FRIDAY, MARCH 10 AT APPROXIMATELY 1640 HOURS, OFFICERS RESPONDED TO CHILDREN'S HOSPITAL AT 1 CHILDREN'S WAY FOR AN UNATTENDED CALL FOR SERVICE. UPON ARRIVAL, OFFICERS MADE CONTACT WITH HOSPITAL STAFF WHO ADVISED THE CHILD HAD INJURIES CONSISTENT WITH TRAUMA. IT WAS DISCOVERED THE FATHER, DEMETRICK GREEN, B/M (DOB: 11/08/1992) CAUSED INJURY TO THE CHILD. AFTER INVESTIGATION, MR. GREEN WAS CHARGED WITH BATTERY 1ST DEGREE Y FELONY. PER STAFF, INJURIES WERE CONSISTENT WITH VIOLENT SHAKING. NO FURTHER POLICE ACTION TAKEN. MVR AND BWC IN USE.

On March 12, 2023, Demetrick Green III succumbed to his injuries. He was pronounced by Dr. Clair Foster At 1120 hours. The body will be transported to the Arkansas State Crime Lab for an autopsy. This investigation is ongoing.

Demetrick Green Jr. charge of Battery 1st was upgraded to Capital Murder, Per findings from the Medical Examiners office.
