NARRATIVE

ON MARCH 30, 2023, APPROXIMATELY 0938 HOURS, OFFICERS RESPONDED TO 813 VALMAR FOR A "SHOOTING JUST OCCURRED" CALL FOR SERVICE. OFFICERS ARRIVED AND MADE CONTACT WITH MS. POINDEXTER WHO INITIALLY STATED MR. DAVIS SHOT HIMSELF ON ACCIDENT. MR. DAVIS WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU RESPONDED TO BEGIN A PRELIMINARY INVESTIGATION. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. DAVIS' BODY AND TRANSPORTED HIM TO THE ARKANSAS STATE CRIME LAB FOR AN AUTOPSY. BASED ON THE EVIDENCE ON SCENE AND MS. POINDEXTER'S STATEMENT, MS. POINDEXTER WAS CHARGED WITH MURDER IN THE SECOND DEGREE AND TRANSPORTED TO PCRJ.
