## **NARRATIVE**

ON SATURDAY, JULY 29TH, 2023 AT APPROXIMATELY 1849 HOURS, OFFICERS RESPONDED TO A SHOOTING IN PROGRESS CALL FOR SERVICE AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED ELIGIAH LUCAS (B/M; 03/26/1997) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MR. LUCAS WAS PRONOUNCED DECEASED ON SCENE. OFFICERS MADE CONTACT WITH HARRIS MARTIN (B/M; 03/16/2000) ON SCENE. MR. MARTIN WAS DEVELOPED AS A SUSPECT AND TRANSPORTED TO MAJOR CRIMES FOR FURTHER INVESTIGATION. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE AND WITNESSES. MR. MARTIN WAS MIRANDIZED AND PROVIDED A RECORDED STATEMENT. MR. MARTIN WAS SUBSEQUENTLY RELEASED WITHOUT CHARGES PENDING A FILE REVIEW. THE PULASKI COUNTY CORONER'S OFFICE TOOK POSSESSION OF MR. LUCAS FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
