## **NARRATIVE**

ON THURSDAY, OCTOBER 12TH, 2023 AT APPROXIMATELY 1948 HOURS, OFFICERS RESPONDED TO A SHOTS FIRED CALL FOR SERVICE IN THE AREA OF THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED MARIO COLLINS (B/M; 06/11/1983) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED, HOWEVER, MR. COLLINS WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE AND WITNESSES. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. COLLINS FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ONGOING.
